THE FRIST CENTER ESTABLISHED AN "ENDOWMENT" DURING 2016, UPON AGREEING TO ACCEPT A PERMANENTLY RESTRICTED CONTRIBUTION FROM A DONOR. THE PURPOSE OF THIS ENDOWMENT, AS SPECIFIED BY THE DONOR, IS TO PROVIDE ANNUAL SUPPORT FOR EXHIBITIONS IN THE CONTEMPORARY ARTISTS' PROJECT GALLERY ("CAP GALLERY"). AS PROVIDED IN THE CONTRIBUTION AGREEMENT EXECUTED WITH THE DONOR, THE FRIST CENTER SHOULD OVERSEE THE ENDOWMENT BY ATTEMPTING TO PRESERVE THE ORIGINAL FAIR VALUE OF THE CORPUS. IN ACCORDANCE WITH THE CONTRIBUTION AGREEMENT, THE FRIST CENTER TRANSFERRED THE ENDOWMENT FUNDS (\$199,600) TO THE VISUAL ARTS FOUNDATION FOR POOLING WITH THE EXISTING INVESTMENT PORTFOLIO FOR INVESTMENT MANAGEMENT PURPOSES. ANY FUTURE APPRECIATION OR DEPRECIATION IN FAIR VALUE IS TO BE DETERMINED IN A MANNER CONSISTENT WITH THE OTHER FUNDS DEPOSITED BY THE FRIST CENTER WITH THE VISUAL ARTS FOUNDATION.
