THE PURPOSE OF THIS ARRANGEMENT IS TO ALLOW THE PROFESSIONAL INVESTMENT MANAGERS WHO OVERSEE THE FOUNDATION'S INVESTMENTS TO ALSO INVEST AND MANAGE THE FRIST ART MUSEUM'S FUNDS AVAILABLE FOR INVESTMENT. ACCORDINGLY, THE FRIST ART MUSEUM'S OBJECTIVE IS TO INCREASE ITS INVESTMENT YIELD AND REDUCE ITS CASH CONCENTRATION IN BANK DEPOSITORY ACCOUNTS. FUNDS OF THE FRIST ART MUSEUM THAT ARE HELD UNDER THIS ARRANGEMENT ARE SUBJECT TO INCREASE OR DECREASE FOR AN ALLOCABLE SHARE OF THE APPRECIATION OR DEPRECIATION IN FAIR VALUE OF THE SPECIFIED INVESTMENTS HELD IN THE FOUNDATION'S INVESTMENT PORTFOLIO. GENERALLY, FRIST ART MUSEUM FUNDS ON DEPOSIT ARE REPAYABLE BY THE FOUNDATION WITHIN 30 TO 60 DAYS AFTER RECEIVING THE FRIST ART MUSEUM'S WITHDRAWAL REQUEST. DURING 2017, MANAGEMENT RECORDED ESTIMATED APPRECIATION OF \$273,827, WHICH INCREASED THE ESTIMATED FAIR VALUE OF THE FRIST ART MUSEUM'S CUMULATIVE AMOUNT ON DEPOSIT TO \$2,349,155 AT DECEMBER 31, 2017.

THE FRIST ART MUSEUM ESTABLISHED AN ENDOWMENT DURING 2016, UPON AGREEING TO ACCEPT A PERMANENTLY RESTRICTED CONTRIBUTION FROM A DONOR. THE AGREEMENT WITH THE DONOR PROVIDES THAT THE ENDOWMENT FUNDS MAY BE POOLED WITH THE FOUNDATION'S INVESTMENT PORTFOLIO FOR INVESTMENT

MANAGEMENT PURPOSES. ACCORDINGLY, THE ENDOWMENT FUND REPORTED IN SCHEDULE D, PART V IS HELD BY THE FOUNDATION.

IN ADDITION, MANAGEMENT WILL PERIODICALLY TRANSFER FUNDS CONTRIBUTED BY DONORS TO THE FOUNDATION FOR INCLUSION IN ITS INVESTMENT PORTFOLIO, PRINCIPALLY IN RESPONSE TO THE DONOR'S AUTHORIZATION OR THE DONOR'S INTENDED USE OF THE FUNDS FOR LONG-TERM SUPPORT. TRANSFERRED FUNDS ARE INCORPORATED INTO THE INVESTMENT PORTFOLIO OF THE FOUNDATION AND MANAGED ACCORDING TO ITS INVESTMENT POLICY. DURING THE YEAR ENDED DECEMBER 31, 2017, THE FRIST ART MUSEUM TRANSFERRED \$25,000 TO THE FOUNDATION FOR LONG-TERM INVESTMENT IN THE ENDOWMENT PORTFOLIO.
